- 5. What is Subaltern Studies? What is its contribution to the historiography of Colonial India?
- 6. What role did Muslims play in the politics of Indian nationalism?
- 7. What are the truth claims of history (as a discipline)? How far are those claims tenable?

- 6. Discuss the features of non-agricultural production in Medieval India.

- 8. How did Gandhi intervene in the anti-indigo planter agitation in Champaran?
- 9. Describe the nature of Vallabhbhai Patel's leadership of the Bardoli Satyagraha.
- 10. Is objectivity possible in history-writing?
