Sciences & Technology of Jammu, Chatha (J&K) -180009** by or before **18<sup>th</sup> of March, 2013** upto 5 p.m. No application form shall be received in this office by hand except in-service candidates of the SKUAST-J.
- Applications received after expiry of the said date will not be entertained.
- Two self-addressed envelopes of size (9' x 4') duly affixed with postage stamps of ₹30/ each should be enclosed with the application form.
- Envelope containing the application form should be subscribed as "**APPLICATION FOR THE POST OF \_\_\_\_\_**".
- Eligible candidates will be informed about date and place of interview through intimation under Registered/Speed post/email. However, University does not take any responsibility for non-receipt or delayed receipt of the application or intimation about interview by a candidate. However the dates of interviews would also be displayed on the website of the University.

- Candidates must do their NAAS (National Academy of Agricultural Sciences) rating of 2012 themselves while submitting their application form. **Application form without NAAS rating will be rejected without assigning any reason.**
- The candidates are further advised to attach all the necessary documents as required with the Application Form in their support.
- All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess, at least the essential qualifications prescribed for each post.
