Standard terms & Conditions for contractual Appointment:

1. The appointment is purely on contract basis for a period of one year or till the regular incumbent joins, whichever is earlier, with effect from the date of joining. Thereafter, the contract will lapse automatically. The appointment can also be terminated at any time on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of the competent authority.
2. The consolidated remuneration will be 1st year Rs.60,000/- & 2nd year Rs.63,000/- per month, if the contract is extended.
3. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and as when required. No extra /additional allowance will be admissible in case of such assignment.
4. The appointee shall not be entitled to any benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc, or any other benefits available to the Government servants, appointed on regular basis.
5. Non-Practice allowance will not be admissible.
6. The appointment will not be granted any claim or right for regular appointment to any post under Central Health Services.
7. The appointee shall be on the whole time appointment of the Institution and shall not accept any other appointment paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
8. The appointment carries with it the liability to serve in any part of the country.
9. The appointment to the said post will be subject to physical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority by the concerned Institute/Hospital before joining the post.
10. The appointee is required to submit the requisition regarding his/her marital status in the prescribed proforma.
11. The leave entitlement of the appointee shall be governed in terms of instructions contained in DOP&T OM No.12016/3/84-Estt. (L) dated the 12th April, 1985, as amended by Om No.12016/1/96-Estt. (L) dated the 5th July 1990.
12. On appointment, the appointee will be required to take an oath of allegiance to the constitution of India to solemn of affirmation to that affect in the prescribed proforma.
13. The appointee is not entitled to any TA for joining the appointment
14. Other conditions of service will be governed by relevant rules and orders issued from time to time
15. If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any material, Information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
